

## NCON 10% WP

## LAMBDA CYHALOTHRIN 10% WP

For public health and household use only. Not to be used on any food crop. NCON 10 WP is a broad spectrum insecticide for use as a residual spray against adult vector mosquitoes of public health importance and control of mosquitoes, houseflies and cockroaches. The active ingredient lambda Cyhalothrin is a novel synthetic pyrethroid developed as a result of extensive search.

**MODE OF APPLICTION:** NCON 10 WP is intended for dilution in water for application as a residual spray using conventional compression sprayer or stirrup pump commonly used in malaria. Programmed by public Health Agenesis. The application is carried out at a pressure of 40 psi. In case of compression sprayer. Half-fill the sprayer with 5 lit of clean water put in the required quantity of 10 WP as directed above stir vigorously with a rod for one minute to mix powder suspension in water. Add further 5 lit of water to fill the bucket. Stir again for one minute. The suspension area of 500 sq.m

**PRECAUTION**: 1) Keep away from foodstuffs, empty foodstuffs

containers and animal food.2) Avoid contact with mouth, eyes and skin. 3) Avoid inhalation the spray mist. Spray in the direction of wind.4) Wash thoroughly the contaminated clothes and parts of the body after spraying.5) Do not smoke, drink, eat and chew

anything while spraying. 6) Wear full protective clothes while mixing and spraying.

**RECOMMENDATION** : It is recommended for Public health use and household use for Mosquitoes, house flies and cockroaches at formulation dosage of 75-150 gm diluted in 10 lit water. And the average waiting period of last application to harvest should be 15-30 days.

SYMPTOMS OF POISONING: Nervousness, anxiety, tremor,

convulsion, skin irritation, allergies, sneezing, running nose and irritation may occur.

**FIRST AID**: 1) if swallowed doesn't induce vomiting or give liquid orally. 2) If clothing and skin are contaminated remove the clothes and wash the contaminated skin with copious amount of soap and water. 3) If eyes are contaminated, flush with plenty of saline/clean water for about 10 to 15 minutes. 4) If inhaled remove the patient to fresh air.

**ANTIDOTE**: No specific antidote is known, treat asymptotically. Antihistamines may be given to control allergies.

**STORAGE**: The package containing the insecticides shall be stored in separate rooms or premise away from the rooms or premises used for storing other articles or shall be kept in separate almirahs under lock and key depending upon the quantity and the nature of the insecticides. The rooms or premises means for storing insecticides shall be well built, dry well lit and ventilated and of sufficient dimensions to prevent environmental contamination with vapor of insecticides.

**PACKING:** The product shall be packed in multilayer film with the capacity of 62.5gm, 75gm and 150gm. The bulk pack of 20 kg is available in drum. Standard packing and match to statutory requirement for product and as per customer requirement.
