4. FIRST AID MEASURES

General Advice

Move out of dangerous area. Place and transport victim in stable position. Remove contaminated clothing immediately and dispose of safely.

Contact with eyes

Rinse immediately with plenty of water, also under the eyelids, for at least 15 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Get medical attention if irritation develops and persists.
